In consideration for the utilizing of the facilities in the engaging in the sport of snow kiting, I hereby understand and agree to this release of liability, waiver of legal rights and assumption of risk and to the terms hereof as follows:

1. I acknowledge that Snow Kiting is an action sport and recreational activity involving travel in three dimensions as such activity is subject to mishap and even injury to participants. I understand I may suffer a broken limb, paralysis or fatal injury while participating in the sport of Snow Kiting. (Initial Here:_____)

I hereby **RELEASE** and **DISCHARGE** all event organizers, the State of NY, the County of Lewis, and their officers, directors, elected officials, agents, employees, instructors, pilots, and owners of equipment and the land used for Snow Kiting activities (hereinafter collectively referred to as “Released Parties”), from any and all liability, claims, demands or causes of action that I may hereafter have for injuries, damages arising out of my participation in Snow Kiting activities, including but not limited to, losses **CAUSED BY THE NEGLIGENCE OF THE RELEASED PARTIES**. I understand and acknowledge that Snow Kiting activities have inherent dangers that no amount of care, caution, instruction or expertise can eliminate and I **EXPRESSLY AND VOLUNTARILY ASSUME ALL RISK OF DEATH OR PERSONAL INJURY SUSTAINED WHILE PARTICIPATING IN SNOW KITING ACTIVITIES WHETHER OR NOT CAUSED BY THE NEGLIGENCE OF THE RELEASE PARTIES** (Initial Here_____).
4. I further agree that I **WILL NOT SUE OR MAKE A CLAIM** against the Released Parties for damages of other losses sustained as a result of my participation in Snow Kiting activities (Initial Here_____).

8. I have read and understood the above and acknowledge that the same constitutes a release of liability and a waiver of my legal rights and also acknowledgement of the assumption of liability by me of all risks arising out of my engaging in Snow Kiting activities

I hereby expressly recognize that this Release of Liability, Waiver of Legal Rights and Assumption of Risks is a contract pursuant to which I have released any and all claims against the Released Parties resulting from participation in Snow Kiting activities including any claims by the negligence of the Released Parties by any of the undersigned (Initial Here_____).
